"Fighting crime used to be a man's job, but more and more women are playing an important role," is this watchdog's quote, suggesting an increase in female crime.

Discussion and results

The criminological signs of female crime include: The spread of mercenary aggression in the structure of female crime. The dependence of the level of female

crime on the socio-economic situation characteristics of different regions of the country. If we consider the crime rate of women and girls by region, it should be noted that the crime rate of women is also increasing in regions with a high general crime rate.³ The size and extent of crime are relatively constant, but increasing. Over the last century, the level (status) of women's crime was five to seven times lower than the corresponding indicators of men's crime. However, in recent years there has been a certain increase in female crime (up to 3% per year). At the same time, the number of women found to have committed a serious crime increased more than fourfold. It is higher (2-3 times) compared to men.⁴ Increased participation of women in committing group crimes (up to 40% of crimes committed by women), as well as an increase in the number of women reoffending (up to 10% of all criminals)

In Keenano, crime has increased significantly in the country. In other words, the number of crimes committed by underage women has increased. It is known from court practice that today there are also cases of brutal murders by groups of 14-15 year old girls. However, the age of the majority of female criminals is still more than 35 years old due to the peculiarities the conditions that determine women's crime. This identity often manifests itself in women's professional environments or in their family and relative relationships. Career and family affect a woman's life after 20 years, and by the age of 30-35, women increasingly feel the manifestation of some of their negative factors, which sometimes determine their criminal manifestations. Provided that we are talking about the problems regarding the prevention of female crime, in general, this problem should be solved within the framework of combating crime. A necessary prerequisite for the success of special measures (programs) to prevent female crime is the achievement of a qualitatively different state of our society. Firstly, a woman in society should occupy a fundamentally different position in life, she should be freed from the role of "producer" of material wealth, which is essentially and even equal to that of men. His strength and attention should be directed towards family and children. The main principles of preventive work with women should be humanity and compassion

Conclusion:

The following conclusion can be drawn from the theoretical justification of female criminality from the perspective of the outside world. First, given the prevalence of female crime worldwide, Adler's suggestion that "women possess masculine characteristics and participate in crime" is dubious or, at best, inappropriate. Women who experience ongoing victimization in their families or in society often turn to crime. Second, women were pushed to a lower social status due to an increase in family disputes, divorces, ongoing victimization, and economic disparities. As a result, there is an increase in the number of female criminals. Accordingly, when analyzing the research findings from a theoretical

standpoint, Chesney-Lind's marginalization theory holds up better empirically when it comes to explaining why women commit crimes around the world.
